The parties to this agreement enter into this partnership on the twenty-third (23rd) day of March 2012. TSF Radio Network, LLC will host an event under the name of North Carolina Passing League on the thirtieth (30th) of June 2012 at Erwin High School.

NCPL agrees to the following:

- NCPL accepts all financial responsibility for the hosting of the event;
- NCPL agrees to provide a current certificate of liability insurance certificate of no less than \$1,000,000 of general liability coverage with \$5,000 medical payment endorsements;
- NCPL agrees to donate \$500 to the ERWIN Athletic Department or ERWIN BOOSTER CLUB, Quarterback Club, or other school-designated organization. Payment will be made to organization, not any individual.
- NCPL agrees to provide staffing for the game-management of the event;
- NCPL agrees to compensate game officials;
- NCPL agrees and strongly encourages that ERWIN engage in athletic department/booster club fundraising opportunities, including but not limited to

concession sales, admission to the venue, and other fundraising activities. NCPL relinquishes any and all fiduciary claim to monies generated by these activities on behalf of ERWIN. As such, ERWIN absolves NCPL from any and all liability from these fundraising activities.

-NCPL has contracted with the U.S. Army Columbia (SC) Recruiting Battalion to host this event FREE of charge for the participating high schools, which may number 16-20 teams and agrees that NCPL is the sole entity responsible for fulfilling the provisions of its contract with the U.S. Army Columbia (SC) Recruiting Battalion and absolves ERWIN of any liability resulting from NCPL's negligence in fulfilling the provisions of the contract.

-NCPL reserves the right to contract with additional local, regional, and national sponsors for the event, but agrees that all sponsors must meet the final approval of ERWIN.

-NCPL agrees to abide by the Buncombe County Board of Education's provisions for the Community Use of School Facilities (530-530R)

ERWIN agrees to the following provisions of this agreement:

-ERWIN, partnership with NCPL, agrees to host 16-20 team tournament, providing NCPL with access to two fields, including the artificial turf field at ERWIN bathroom facilities, concessions, locker rooms, press box, scoreboard, and any reasonable access to any other building on-site to ensure a safe event for the participating student-athletes;

-ERWIN agrees to provide NCPL game-day logistical support for the event.

-ERWIN agrees to allow the NCPL to engage in reasonable marketing activities involving the U.S. Army, including: placing banners throughout the facility; positioning of tents at the facility; and distributing U.S. Army materials to the participating student-athletes and fans.

-ERWIN reserves the right of approval for any additional sponsors if they do not conform to the provisions the Buncombe County Board of Education's policy on the Community Use of School Facilities.
