The parties to this agreement enter into this partnership on the 9th day of MAY 2012. TSF Radio Network, LLC will host an event under the name of the U.S. Marine Corps – Passing League Maryland on the date of July 14, 2012 at Coolidge High School.

The PLM agrees to the following:

- PLM accepts the financial responsibility for the hosting of the event;
- PLM agrees to provide a current certificate of liability insurance certificate of no less than \$2,000,000 of general liability coverage with \$100,000 excess medical payments;
- PLM agrees to list HOST school and HOST school district as an additionally insured party;
- PLM agrees to provide staffing for the game-day management of the event;
- PLM agrees to compensate medical personnel for the event;
- PLM agrees and strongly encourages that HOST engage in athletic department/booster club fundraising opportunities, including but not limited to concession sales, admission to the venue, and other fundraising activities. PLM relinquishes any and all fiduciary claim to monies generated by these activities on behalf of HOST. As such, HOST absolves PLM from any and all liability from these fundraising activities.

- PLM has contracted with the U.S. Marine Corps, Recruiting Station Baltimore to host this event FREE of charge for the participating high schools, which may number 16-20 teams and agrees that PLM is the sole entity responsible for fulfilling the provisions of its contract with the Marine Corps and absolves HOST of any liability resulting from PLM's negligence in fulfilling the provisions of the contract.

- PLM reserves the right to contract with additional local, regional, and national sponsors for the event, but agrees that all sponsors must meet the final approval of HOST.

- PLM agrees to abide by the School District's provisions for hosting event at HOST site.

HOST agrees to the following provisions of this agreement:

-HOST, in partnership with PLM, agrees to host 16-20 team tournament, providing PLM with access to two fields, including an artificial turf field, bathroom facilities, concessions, locker rooms, press box, scoreboard, and any reasonable access to any other building on-site to ensure a safe event for the participating student-athletes;

-HOST agrees to provide PLM with limited game-day logistical support for the event.

-HOST agrees to allow the PLM to engage in reasonable marketing activities involving the Marine Corps, including: placing banners throughout the facility; positioning of tents at the facility; and distributing Marine Corps materials to the participating student-athletes and fans.

-HOST agrees to assist PLM with the securing secondary fields for the event from the D.C. Parks & Recreation. If necessary, PLM will pay a reasonable fee for use of secondary fields.

-HOST reserves the right of approval for any additional sponsors if they do not conform to the standards set forth by the School District.

-HOST agrees to accept consideration of a \$500 donation to the HOST school, the HOST school's school district, or fundraising organization designated by HOST school.
