NETWORK agrees to the following:

1. NETWORK agrees to deliver eight (8) sports reports each weekday for AFFILIATE, excluding agreed upon holidays, including but not limited to: Christmas, New Year's Day, et al;
2. NETWORK agrees to deliver four (4) morning sports reports and four (4) afternoon sports reports for AFFILIATE each weekday;
3. NETWORK agrees to deliver updates to AFFILIATE in exchange for the consideration of three (3) sixty-second (60) commercials each weekday on AFFILIATE or fifteen (15) sixty-second commercials each week;

4. NETWORK agrees that AFFILIATE will air NETWORK commercials run-of-schedule (ROS), Monday-Sunday, 5A-7P, and provide NETWORK with an affidavit of performance for the airing of the NETWORK commercials;
5. NETWORK will provide traffic instructions for the barter commercials;
6. AFFILIATE has the unlimited right to sell local sponsors to the NETWORK reports, and NETWORK anchors will include the AFFILIATE's local sponsors in the opening and closing billboards of our NETWORK reports.
7. AFFILIATE is responsible for providing accurate copy to the NETWORK.
8. AFFILIATE assumes all fiduciary responsibility for the local sponsorships that are included in the NETWORK reports;
9. NETWORK agrees that this is a market-exclusive contract for the St. Louis DMA.

AFFILIATE agrees to the following:

1. Air NETWORK sports reports on AFFILIATE;
2. Air NETWORK barter commercials run-of-schedule (ROS), Monday-Sunday, 5A-7P on AFFILIATE station;
3. Provide NETWORK with three (3) sixty-second (60) barter commercials each weekday or fifteen (15) sixty-second barter commercials each week on AFFILIATE, and agrees to air the NETWORK commercials ROS, Monday-Sunday, 5A-7P.
4. Provide NETWORK with an affidavit of performance for the NETWORK's barter commercials.

NETWORK and AFFILIATE agree to a ONE-YEAR contract with the start date of January 6, 2014 or January 13, 2014, as determined by the parties to the contract. Either party can terminate the contract with a written notification, including via e-mail, 30 days prior to contract's termination.

NETWORK agrees to abide by AFFILIATE'S commercial policies, provided that the AFFILIATE provides those policies to the NETWORK.

NETWORK agrees to the guidelines contained in this BARTER AGREEMENT. With the above signature of the designated AFFILIATE representative, the AFFILIATE agrees to the terms of this BARTER AGREEMENT.
