NETWORK agrees to the following:

1. Delivery of two (2) three-minute (3:00) updates for affiliate station KNNK-FM, Monday-Friday. The reports will include two-minutes (2:00) of local content with a one-minute (1:00) commercial adjacency.
2. Delivery of two (2) one-minute-fifty-five second (1:55) updates for affiliate station KNNK-FM. The reports will include 55-seconds of content with a one-minute (1:00) commercial as an adjacency.
3. Delivery of Monday-Friday, War Hawk Sports Report for the War Hawk Sports Network stations, including: KNNK-FM; KAXT-FM; KLVT-AM; and KZZN-AM. The War Hawk Sports Report will be one

four-minute feature with three-minutes (3:00) of content with a one-minute (1:00) commercial adjacency.

4. AFFILIATE has unlimited rights to the WAR HAWK SPORTS REPORT and can air the update on all of its stations an unlimited number of times and can include the update online for download as long as the NETWORK commercial remains as an adjacency.

AFFILIATE agrees to the following:

1. Air NETWORK sports reports on KNNK-FM with commercial attached as an adjacency a minimum of four times each weekday;
2. Air NETWORK's War Hawk Sports Report with NETWORK commercial as an adjacency on network affiliate stations;
3. Notify NETWORK of any additional network affiliates that air WAR HAWK Sports Report;
4. Air NETWORK reports with NETWORK commercial as a self-contained feature.

NETWORK and AFFILIATE agree to a ONE-YEAR contract with the starting date of November 26, 2012. Either party can terminate the contract with a written notification, including via e-mail, 30 days prior to contract's termination.

NETWORK agrees to abide by AFFILIATE'S commercial policies, provided that the AFFILIATE provides those policies to the NETWORK.

NETWORK agrees to the guidelines contained in this BARTER AGREEMENT. With the above signature of the designated AFFILIATE representative, the AFFILIATE agrees to the terms of this BARTER AGREEMENT.
