NETWORK agrees to the following:

1. Delivery of six(6) sports reports each weekday with three (3) morning reports and three (3) afternoon reports for each AFFILIATE radio station;
2. AFFILIATE has the option of airing the updates in the following manner, please choose one of the following:
 - 2.a _____ Self-contained feature with one-minute(1:00) of content followed by a one-minute (1:00) NETWORK commercial;
 - 2.b _____ One-minute (1:00) of content without the NETWORK commercial as an adjacency, but AFFILIATE agrees to air three (3) NETWORK commercials each weekday, ROS,

Monday-Friday, 6a-7p. In which case, NETWORK will provide AFFILIATE with traffic instructions for ROS commercials and will provide NETWORK with an affidavit of performance for the airing of NETWORK commercials;

3. AFFILIATE has unlimited rights to air the NETWORK update;
4. AFFILIATE has the right to sell local sponsors to the NETWORK reports, and NETWORK anchors will include the AFFILIATE sponsors in the opening and closing billboards of our NETWORK reports. AFFILIATE is responsible for providing accurate copy to the NETWORK.

AFFILIATE agrees to the following:

1. Air NETWORK sports reports and NETWORK commercials as specified in sections 2.a or 2.b;
2. IF 2.a, AFFILIATE agrees to air NETWORK reports a minimum of three (3) times each weekday on AFFILIATE with NETWORK commercial as a self-contained feature;
3. IF 2.b, AFFILIATE agrees to air three (3) one-minute (1:00) NETWORK commercials each weekday ROS, Monday-Friday, 6a-7p;
4. Total NETWORK inventory shall not exceed three (3) one-minute (1:00) commercials each weekday on NETWORK affiliate or 15 total for each week.

NETWORK and AFFILIATE agree to a ONE-YEAR contract with the starting date of JULY 1, 2013 or on the date specified here:_____. Either party can terminate the contract with a written notification, including via e-mail, 30 days prior to contract's termination.

NETWORK agrees to abide by AFFILIATE'S commercial policies, provided that the AFFILIATE provides those policies to the NETWORK.

NETWORK agrees to the guidelines contained in this BARTER AGREEMENT. With the above signature of the designated AFFILIATE representative, the AFFILIATE agrees to the terms of this BARTER AGREEMENT.
