NETWORK agrees to the following:

1. Delivery of six (6) sports reports each weekday for AFFILIATE radio station exchange for a minimum of three (3), 60-second barter commercials each weekday on each AFFILIATE station.
2. AFFILIATE will air three (3) reports in the mornings and three (3) reports in the afternoons on AFFILIATE station;
3. AFFILIATE has the right to sell local sponsors to the NETWORK reports, and NETWORK anchors will include the AFFILIATE sponsors in the opening and closing billboards of our NETWORK reports. AFFILIATE is responsible for providing accurate copy to the NETWORK.

- (a) _____ NETWORK will include its COMMERCIAL with the delivery of the daily update as a self-contained feature; or.
- (b) _____ NETWORK will traffic its barter COMMERCIAL, sending AFFILIATE traffic instructions for the airing of NETWORK commercials.

AFFILIATE agrees to the following:

1. Air NETWORK sports reports and NETWORK commercials a minimum of three (3) times each weekday on AFFILIATE;
2. Air NETWORK reports with NETWORK commercial as a self-contained feature or air the NETWORK commercials, run-of-schedule, Monday-Friday from 6 A – 7P.
3. Provide NETWORK will an affidavit of performance for the airing of the NETWORK commercials, if necessary.

NETWORK and AFFILIATE agree to a ONE-YEAR contract with the starting date of March 11, 2013. Either party can terminate the contract with a written notification, including via e-mail, 30 days prior to contract's termination.

NETWORK agrees to abide by AFFILIATE'S commercial policies, provided that the AFFILIATE provides those policies to the NETWORK.

NETWORK agrees to the guidelines contained in this BARTER AGREEMENT. With the above signature of the designated AFFILIATE representative, the AFFILIATE agrees to the terms of this BARTER AGREEMENT.
